Title, language and number of pages of the notified document: Industry Notice: Expansion of Implementation of the <i>International Standard for Phytosanitary Measures (ISPM) # 15: Guidelines for Regulating Wood Packaging Material in International Trade (ISPM 15) to Air and Break Bulk Cargo to Cover All Wood Packing and Dunnage for Imports into Australia.</i> (available in English, 1 page).
6.	<p>Description of content: Australia currently accepts wood packing for containerised cargo according to the <i>International Standard for Phytosanitary Measures No. 15: Guidelines for Regulating Wood Packing Material in International Trade (ISPM 15)</i>. Australia now proposes to extend the adoption of ISPM 15 to cover all wood packing material and dunnage used in supporting, protecting or carrying break bulk and air cargo imported into Australia.</p> <p>For countries unable to comply with ISPM 15, Australia will continue to accept packaging which meets existing AQIS requirements for containerised cargo only. In the event of non-compliance with respect to wood packaging associated with break bulk and air cargo, the timber will be treated, destroyed or re-exported. Additionally, inspection will no longer be offered as an option for any imported wood packing and/or dunnage regardless of the mode of transport.</p> <p>In addition to the ISPM 15 measures, Australia will maintain the following existing requirements:</p> <ul style="list-style-type: none">• freedom from bark; and• methyl bromide fumigation at 48 grams per cubic metre for 24 hours (not 16 hours) and the timber at time of treatment being no greater than 200mm in diameter in the smallest plane. <p>Australia will re-evaluate its required treatment period of 24 hours after the findings of an international review of the methyl bromide treatment specified under the ISPM 15 standard have been released.</p>
