Citizens of the Czech Republic and their family members who are holders of a temporary residence permit, EU+ citizens who are holders of a certificate of a temporary residence and foreign nationals with a permanent residence permit in the Czech Republic.



**Groups of persons,** who do not have the obligation to undergo testing and self-isolation after the arrival:



exception from

persons fully vaccinated in the EU+ countries - 14 days after the application of the last dose (it is necessary to have a national certificate or a digital EU certificate)

Czech citizens and EU+ citizens fully vaccinated in a third country with the EMA approved vaccination when it is at least 14 days after the application of the last dose (it is necessary to have a certificate whose sample is published on the Ministry of Health website)

Citizens and residents of Czechia can enter the country even in case of a positive test before arrival. Rules for transport with a positive test are described in the Ministry of Health Protective Measure.
