Testing after arrival to the Czech Republic - within 5 days after arrival from countries with low or madium risk and 5th day after the arrival from a country with high or very high risk at the earliest

Travellers from all countries have an obligation to fill in the Passenger Locator Form before the arrival.



There are several exceptions from the obligation to fill in the Passenger Locator Form or undergo testing. All the rules and exceptions can be found in the Ministry of Health Protective Measure.



A list of countries with low, medium and high risk of Covid-19 transmission and list of countries with an extreme risk of Covid-19 transmission can be found here. A country listed in neither list of countries is considered as a country with a very high risk of Covid-19 transmission.





Groups of persons, who do not have the obligation to undergo testing and self-isolation after the arrival:



persons fully vaccinated in the EU+ countries - 14 days after application of the last dose (it is necessary to have a national certificate or a digital EU certificate)
